- Stay in touch with colleagues as well as the latest professional developments

1. To support the development of the coach
2. To support clients and their work through the supervisory process
3. To develop new insights, tools and techniques for coaching interventions
4. To raise awareness of personal issues and how they may limit your effectiveness

Supervision Groups

Using the group format to understand the personal and systemic dynamics involved, AoEC Supervision Groups provide YOU with opportunities to:

1. Bring client issues that may be confusing or complicated or may involve complex boundary management and/or ethical considerations
2. Deepen understanding of self and how your own limitations can inhibit the development of the client system.

3. Explore the coach-client dynamic and deepen and broaden the range of ways of working with your client
4. Deepen your understanding of *self* in contact with your client
5. Explore the supervisor – coach dynamic and understand and learn from the nature and the parallel process
6. Further develop and hone coaching skills and models, add to the coaching tool – kit through theory input
